### Key points of the 2023 Budget:

Items of note going forward for the 2023 Budget include the establishment of \$25,000 Conference Reserve Fund, new funds to support the Denis Salter Grants, setting up CATR with QuickBooks – eliminated some unused categories and added some new ones, TheatreAgora's redesign with Koumbit, and recommending raising membership fees for 2024.

### **Discussion and Questions**:

As a percentage of someone's income, Neil points out that the proposed increase has a greater impact on lower income earner members.

The membership increases proposed for 2024 are not covered by the projected 2023 budget here. The rebalance of membership increases will be revisited in the September board meeting.

Thanks to Katrina for all her work in updating the accounting practices.

### **Discussion and Questions**:

Struck by the conference budget being 90,000 that there were significant increases essentially has doubled the cost of what it was pre-pandemic. 1) What accounts for the significant increase in the conference budget and 2) What are we doing for the sustainability of the conference.

Most of the costs associated with the conference in the past have been buried or subsumed by the institution, Katrina has been working to make explicit these expenses that, in the past have not normally been included in the budget. There is an increased investment in paying a support staff to address the crisis in volunteering and the overwhelming reliance on those who are in precarious positions.

The institutional costs of 2018 were not buried in the budget, there are still concerns here and there and the budget needs to be clearer.

Where some of these costs involving the technical costs associated with developing the website and running the online parts – involved with the hybridity and TheatreAgora.

An invitation to membership to give feedback to the Treasurer about the costs.

Some critical budget points to note include:

- The cost of food is \$45/person and the consideration for our precarious folk. There is a general thanks for considering the needs of precarious scholars and recognizing the need for a reasonable food budget.
- Inflation is also increasing.
- Is there an implicit expectation for future hosts to apply for the SSHRC connection grant and would that be a deterrent. This is a significant time commitment, but at this point this hasn't come up as an issue.

The critical question of how we grow the sources of revenue for the budget and to increase the reserve fund for future sustainability remains.

- Need to think more about re-balancing online and in-person participation, and it is vitally important that people have the opportunity to participate in the way that they can/are able to

### **Discussions and Questions:**

A sincere thanks to Roberta and everyone who has contributed to the conference and to the participants. Grateful to the prompt to rethink the balance – of in-person and hybridity. There is a certain access that is commendable. The onus of labour to do the hybrid and deal with the tech aspects – what is the experience of the person in the zoom of the hybrid. Should we be doing this and what are the underlying values that places the emphasis on the in-person when we have so many precarious members. The problem of being precarious and presenting to less robust audience – discouraging for a new member. There are solutions to intentionally have tenure track people set up.

Conference revisioning committee needs to be struck to consider sustainable pathways for the future. Critical to this process, we need to consider the question: For whom is the Canadian Association for Theatre Research and how should the Association best serve its members?

- Upcoming we are seeking to conduct a survey of precarious members, to offer supportive programming, to build tenure-precarious alliances with a hack-a-thon in collaboration with committee on conduct, to establish a fundraising initiative to support our work
